PRODUCT INFORMATION NOTICE NOTICE OF POSSIBLE UNSAFE CONDITION

100 Amp thru 225Amp QO Loadcentres with CSA marking

Schneider Electric has discovered a material non-conformance with respect to hardware used in certain 100 Amp thru 225 Amp QO Loadcentres with CSA markings manufactured between October 23, 2001 and January 14, 2002. This non-conformity involves the potential for a loose bolted connection on the neutral bar in the mains base assembly. If a loose neutral connection was to occur it may result in higher or lower voltages than normal on a single pole branch circuit(s). Therefore, a potential for **PROPERTY DAMAGE** exists for sensitive electronic equipment.

Stop all sales of the affected product immediately. In accordance with the recommended action on Attachment 1, all affected products in your inventory should be returned in a separate shipment to:
